## DSF<sup>2</sup> and DPV™

Delivery Sequence File\* - Second Generation (DSF²) is an address accuracy tool that identifies addresses that are complete and correct and addresses that are not.

DSF² processing identifies address characteristics that enable marketers to distinguish between residential and business addresses, seasonal addresses, vacant locations and the mail delivery method - curbside delivery, door slot, NDCBU (Neighborhood Delivery and Collection Box Unit) or central delivery.

DSF² assigns walk sequence numbers and provides the documentation necessary to qualify for additional United States Postal Service (USPS®) delivery sequence postage discounts.

A Delivery Point Validation (DPV) module confirms an address is correct and is an actual USPS delivery point. It also identifies the address if it is a Commercial Mail Receiving Agency (CMRA). All DPV functionality is included in DSF<sup>2</sup>. DPV identifies if an address is missing secondary data (Apt#), or contains incorrect secondary data.

## **Key Features:**

DSF² standardizes addresses to meet USPS Automation and Coding Accuracy Support System (CASS™) requirements. The Client file is then matched to over 145 million addresses (delivery points) in the USPS DSF² database.

#### The DSF<sup>2</sup> Process:

- Validates the incoming address as being correct.
- Corrects ZIP and ZIP + 4 codes.
- Verifies Building or Firm name.
- Identifies type of mail receptacle.
- Provides:
  - O A Carrier Route Number.
  - O A Carrier Delivery Sequence Number.
  - O A Delivery Point Barcode (DPBC).
  - O A Business or Residential indicator.
  - O A Seasonal Code indicator.
  - O An Occupied/Vacant Code indicator.

#### Reports Include:

- Footnote and Delivery Type Counts.
- National Deliverability Index.
- Anchor's Deliverability Index Score.
- PS Form 3553 for CASS Certification.

## **Key Benefits:**

- Improves mail deliverability through address standardization and verification at the delivery point level.
- CASS corrects misspelled street names and adds directional indicators and street suffixes.
- Qualifies mail for additional walk sequence and saturation mail postage discounts.
- Saves on postage and material costs by eliminating undeliverable as addressed mail, i.e. non-existent, incorrect, incomplete or undesirable.
- Enhances the Merge/Purge process and improves overall mail deliverability.
- DSF<sup>2</sup> generally enables you to identify 3-6% of your mailing as potentially undeliverable.
